INFORMATION ON THE PROCESSING OF PERSONAL DATA

Pursuant to Art. 13 of Regulation 2016/679 of the European Parliament and of the Council (EU) of 27 April 2016 on the protection of individuals with regard to the processing of personal data (...) ("GDPR") Andrzej Frycz Modrzewski Krakow University informs that:

- 3. Your personal data will be processed for the purpose of your participation in the Erasmus+ program, in particular:
 - a. to the extent necessary to conduct the recruitment process for participation in the Erasmus+ program and to implement the provisions of the concluded agreement, including enabling contact in this regard pursuant to Article 6(1)(b) of the GDPR,
 - b. in order to fulfill the legal obligations incumbent on the Controller in connection with the concluded agreement, including tax and accounting obligations pursuant to Article 6(1)(c) of the GDPR in connection with the relevant provisions of tax law,
 - c. for the purpose of monitoring and evaluating the program, including the preparation of relevant reports, statistics, investigations, or defense against possible claims related to the agreement to participate in the program or the general terms and conditions of the program pursuant to Article 6(1)(f) of the GDPR,
 - d. for the purposes of the Administrator's promotional activities, including the publication of photo reports and video recordings on the Administrator's websites and social media pursuant to Article 6(1)(a) of the GDPR, only if you consent to the dissemination of your image beyond the situations specified in Article 81(2)(2) of the Act of February 4, 1994, on copyright and related rights.
- 4. Providing personal data is voluntary, but necessary for the purposes for which it was collected, and refusal to provide it is tantamount to the inability to participate in the Erasmus+ program. If consent is given, the transfer of data is voluntary, and failure to provide data does not have any negative legal consequences.
- 5. Personal data will not be disclosed to external entities, except in cases provided for by law (in particular: the National Agency of the Erasmus+ Programme and the European Solidarity Corps Foundation for the Development of the Education System (FRSE), partner university and the receiving organization, if you are qualified to take part in the Erasmus + programme), as well as provided for in the agreements concluded between the University and service providers and technical/ organizational solutions (in particular IT service providers).
- 6. Your personal data will be stored until the Erasmus+ program has been settled and the documentation has been archived. If you do not qualify for the program, your personal data will be stored until the end of the recruitment process. In the case of personal data processed based on consent, it will be processed for the period necessary to achieve the purpose indicated in the consent clause or until it is withdrawn. In the case of data processing based on the legitimate interest of the Administrator, personal data will be processed until the expiry of any claims or until an effective objection is lodged.
- 7. You have the right to: access your data and rectify it, restrict processing, transfer data, object to processing in cases and under conditions specified in the GDPR, as well as the right to withdraw your consent at any time. Consent may be withdrawn in writing or electronically sent to the Data Controller.
- 8. Your personal data will not be subject to automated decision making and will not be profiled.
- 9. Your personal data may be transferred to a third country depending on the country that you choose as the place of implementation of the Erasmus+ programme. Furthermore, due to the international nature and scope of entities such as Facebook, Instagram, X, LinkedIn, and YouTube, where photographs/video recordings from the event may be published, my personal data may be transferred to a third country.
- 10. You have the right to lodge a complaint with the President of the Personal Data Protection Office when you feel that the processing of your personal data violates the provisions of the GDPR.
